EnCF Action Plan Tracker

Group reviewed the tracker, items due for review were covered in main agenda

Standardisation Update:

PPSR Legislative Requirements

Spoke to presentation in relation to Pressure Systems Safety Regulations 2000 (PSSR) and HSE ACOP L22 and responsibilities as duty holders under PPSR and the process for written scheme of examination.

TH noted that this piece is a summary and that has been taken through the GDNs as part of Maintenance piece. Information related to be uploaded to ENA website so that it is widely available.

In Grid Compression Commercial and Regulatory:

Commercial

Commercial paper circulated. Some comments back from John – referencing asset ownership (which there are different options for) these would require UNC modification. GDNs need to decide whether they are comfortable with third party ownership, biomethane projects will not be able to go ahead if they are not comfortable, this is a point of facilitation and support.

Capacity is an ongoing issue for biomethane projects and that there is limited focus on in-grid compression. SE noted potentially a transitional piece of work needed about how to get compressors on the grid as promptly as possible.

Technical

Raj was unable to provide technical update/ specification

Next steps are to bring back third party ownership of assets to UNC meeting. The action on the GDNs will come through this group.
