## Recent Industry Developments and ON impact

Maxine Frerk (Challenge Group Chair) invited the Group to flag any industry developments that ON should be aware of. Industry developments flagged will be discussed with ON Steering Group and any subsequent actions reported to the Challenge Group in the next meeting.

Feedback	Response
Challenge Group flagged open Ofgem CFI on the Futue of Distributed Flexibility and consultation on Local Energy Institutions and Governance had been published on the morning of this meeting.	The two industry developments and Challenge Group support were noted. ON will continue business as usual until any policy reforms are issued.
The Challenge Group noted that the documents underrepresent ON achivements and noted support for continued work through the programme.	
The Challenge Group will meet independently to discuss their view further.	



### Open Networks 2023 Scope

Avi Aithal (Head of ON) shared a high-level view of ON scope in 2023, and sought Challenge Group views on the <u>2023 launch document</u>. It was highlighted that Challenge Group will be approached to participate in need-based focus groups for key technical working groups, or requested to recommend representatives from their industry sector.

Feedback	Response
The Group noted that the document is easy to consume and welcomed the inclusion of measurable success criteria.	Feedback noted.
Challenge Group requested a clarification on the goal of aligning 80% of DSO flexibility products.	A 20% buffer in the goal allows space for ongoing innovation in the flexibility space, as well as nuances and trials that may apply to specific customers or areas.
Challenge Group enquired whether the outcomes committed to in the document align with DSO incentives.	Some outcomes align with DSO incentives, and others are covered as part of compliance with ON outcomes.
The Group enquired how Community Energy organisations will be engaged beyond the Challenge Group.	ON will host two Community Energy Forums in 2023 in collaboration with Regen. Community Energy England will be engaged as part of this. Challenge Group are seen as a representative of the wider industry.

#### **Standard Agreement**

Andy Rice (NG ESO) & Wendy Mantle (SPEN) (Technical working group Co-Leads) shared 2022 work on service based schedules in the Standard Agreement and the group's 2023 focus, including development of Standard Agreement Ver 3.0.

Feedback	Response
The Group noted the importance of aligned implementation across network companies.	Measure of success for this work will be the aligned implementation of the Agreement across network companies. This is expected to ease operations of providers and networks.
Capacity to deliver a service can change closer to delivery time where services have been procured long in advance. Providers may find it helpful to have more clarity on when liabilities for service failure kick in.	Feedback noted.



### **Primacy Rules**

Matt Watson (NG ED) & Stuart Fowler (NG ESO) (Technical working group Co-Leads) shared updates on Increment 1 and 2 ESO – DSO Primacy Rules currently in development, including TCM vs DSO service conflicts, and STOR vs ANM service conflicts.

Feedback	Response
The Primacy Rules working group should keep the Ofgem CFI on Distributed Flexibility in mind in case this has implications for Primacy.	Feedback noted.
The Group enquired how changes in ANM curtailment will impact Primacy Rules.	The scale of volume under ANM is likely to change. Primacy Rules cost-benefit analysis has looked at five potential scenarios. Increment 1 Rules consider the cost of additional curtailment.
The Group enquired whether setting locational limits to services to minimise grid impact is taken into account.	Locational limits are taken into account where DSOs ask providers in certain areas to become unavailable.
The Group noted speed of deployment as a priority.	Feedback noted.
The Group enquired about the priority of outcome in regards to impact on consumers, speed of imlplementation, or any other priority.	Primacy Rules aim to achieve the lowest regret, best overall system outcome, taking fairness and transparency into account. A number of criteria has been employed to prioritise rule development of individual use cases.

## Implementation of DER visibility

Odilia Bertetti (UKPN, Technical working group Lead) shared recommendations for DER information sharing made in 2022, and the focus on harmonising DER information sharing in 2023.

<ul> <li>however, this should be balanced with not creating too many individual products.</li> <li>A set of standard products will allow providers to more easily set up operational systems for engaging with different products and providers.</li> </ul>
<ul> <li>Community Energy organisations are still in the process of defining how they will participate as providers. It is likely that additional feedback on how product specifications affect them will emerge later.</li> </ul>
